Sub:-Non re-imburement of payment to BSNL in lieu of rental on the land and buildings under possession of DOT-case of implementation of 3rd PRC.

Respected Sir/Madam,

It is humbly submitted that there are hundreds of DOT offices all over India which are under possession of DOT, TRAI, and Term Cell etc from the last 17 years.

At the time of formation of BSNL, all asset and liabilities have been transferred to BSNL including land and buildings. It clearly stated all these building are under the preview of BSNL from 01-10-2000.

BSNL is forced to pay all charges including spectrum charges (3G spectrum) etc at the highest of bid amount to DOT without taking any consent from BSNL based on Financial viabilities .

Different Government offices are running from these building. BSNL is regularly paying all maintenance charges including Electric bill against these land and buildings running into thousands of Crores from last 17 years.

DOT are still not paying any rent, maintenance charges, electric bill etc against these land and buildings. It is also matter of audit and loss of revenue to BSNL.

Moreover, as per recommendation of the committee, 3rd PRC is directly linked with profitability of concerned PSU, so implementation of 3rd PRC effected from balance sheet of BSNL due to non paying of pending due from different wing under DOT to BSNL. It may be in the tune of hundreds of crores.

BSNL Management dominated by DOT officers failed to raise the invoices against the these buildings rendered by BSNL

It is one of the reasons that financial efficiency of BSNL is suffered and BSNL employees are devoid of perks and partial implementation of 2nd PRC.

It is further informed that Sole Motto of our Association to work for the safeguard the interest the BSNL in legal framework.

Keeping in view the above facts in mind, Our Association/Union demand to Government of India to fully cleared all pending dues along with interest running into hundreds of crores to BSNL so that

Company may be able to implement its 3rd PRC otherwise TOA (BSNL) constraints to raised the issue with the Controller and Auditor General of India for the audit of this Financial loss to BSNL.

Therefore, it is humbly submitted and requested to consider our demand/request for the benefit of BSNL and its employees.
